Members in more than 70 countries, IBIA is the backbone of the global bunker industry. It represents stakeholders across the industry value chain. Their membership includes ship owners / operators, bunker supplies, traders, brokers, barging companies, storage companies, surveyors, port authorities, credit reporting companies, lawyers, P&I clubs, equipment manufacturers, shipping journalists and marine consultants. It represents the industry as a consultative non-governmental organisation at the International Maritime Organization

IBIA has also been granted "liaison status" with the International Standards Organisation (ISO). This enables IBIA to contribute to discussion regarding ISO 8217 and ISO 13739.

IRS Certified Barge

Founded in 1975, Indian Register of Shipping (IRS) is an internationally known society which classifies ships. It is a non-profit organisation and a Public Undertaking. Also, part of the 13-member International Association of Classification.

In terms of regulatory compliance, bunkering of ships is a highly focused shipboard operation. The Directorate General of Shipping (Govt. of India) has introduced comprehensive procedures for regulation, registration and monitoring of Bunker Suppliers in the Indian Coast. The Directorate General of Shipping undertakes verification survey of Bunker Suppliers for Registration as Bunker Suppliers. Accordingly, it carries out surveillance audits of Bunker Suppliers and on satisfactory completion of surveillance audits, recommends issuance of certification to the Directorate General of Shipping.

Upon nomination, we procure the quality bunker from IOCL, BPCL or HPCL and supply it by tank trucks and barges. We own a total of 12 tank trucks of 20KL capacity each.

We ensure that we provide Quality assured Marine Gas Oils and Fuel Oils. All our products are sourced from Indian Oil Corporation Limited (IOCL), Bharat Petroleum Corporation Limited (BPCL) and Hindustan Petroleum Corporation Limited (HPCL).

Our Products:

- IFO 380 (Intermediate Fuel Oil): A mix of 88% of residual oil and 12% of distillate oil.
- IFO 180 (Intermediate Fuel Oil): A mix of 98% of residual oil and 2% of distillate oil.
- MDO (Marine Diesel Oil): It mainly consists of distillate oil and has a lower sulphur content than the three fuels described above.
